Illinois Broker 75 Hour Pre-License Course Fall 2026

Effective May 1, 2011, the Real Estate Broker License replaced the former Illinois Real Estate Salesperson license. A Real Estate Broker must always be employed by a Sponsoring Broker and work under the direction of a Managing Broker.

COURSE DESCRIPTION

The Illinois Real Estate Broker Pre-License Course was designed to meet the 75-hour curriculum requirement for real estate brokers as set forth by the State of Illinois.

The course, which is geared toward adult learning, encompasses 60 hours of pre-license topics and 15 hours of broker applied real estate principles.

The course covers topic areas such as Illinois license law, agency, state and federal law, relationships with employing brokers, working with buyers and sellers, real property, fair housing, ownership, contracts, real estate valuation, environmental issues, construction, real estate closing, advertising, property management, and commercial real estate.

LICENSING REQUIREMENTS

Complete required 60-hour Broker Pre-license & 15-hour Interactive coursework

Be 18 years of age

Have a high school diploma or equivalent

Pass the state licensing exam with a score of 75% or higher

Be sponsored by a licensed managing broker in Illinois

POST-LICENSING REQUIREMENTS

After receiving your broker license number, if issued between November 1, 2025 and October 31, 2027, You will be required to take the new 45-hour Broker Post-License courses prior to the April 30, 2028, renewal deadline.

SCHOOL POLICY

Attendance is required at all sessions.

Students may not miss more than 10% of the class.

All missed class time must be made up before the last scheduled date of classes.
